This discharge, waiver and release includes claims, demands and liabilities that are known or unknown, foreseen or unforeseen, future or contingent, and includes claims, demands, and liabilities arising out of the negligence of the parties so released by such member. The undertakings and covenants of the foregoing provisions shall be binding upon each member, his or her heirs, legal representatives, successors, and assigns.
